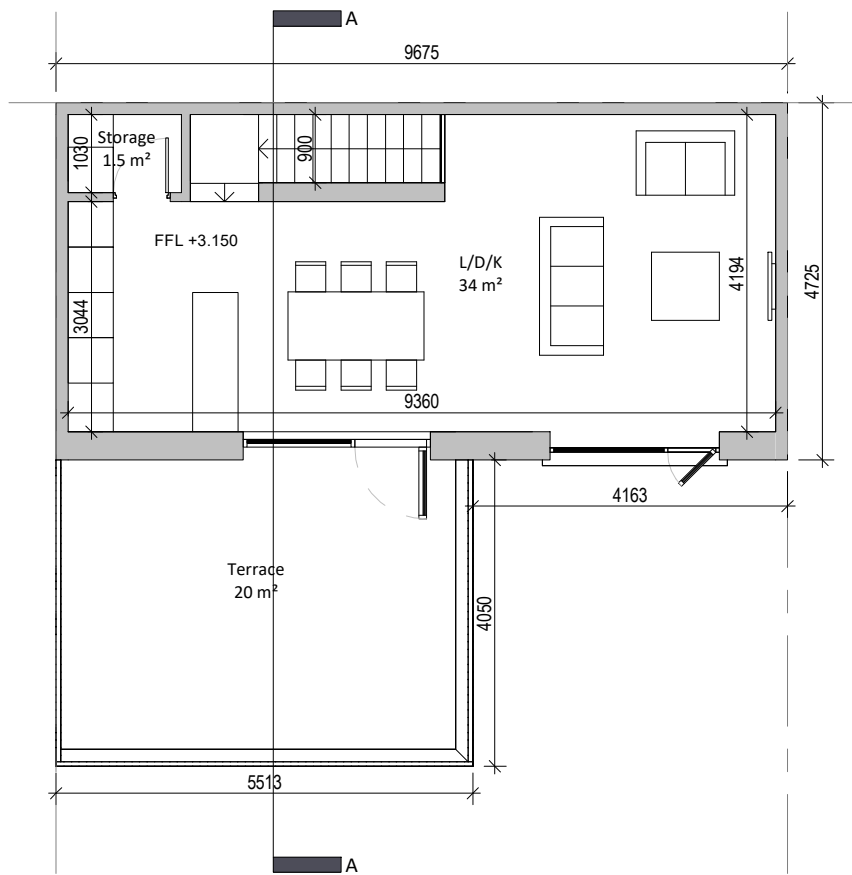


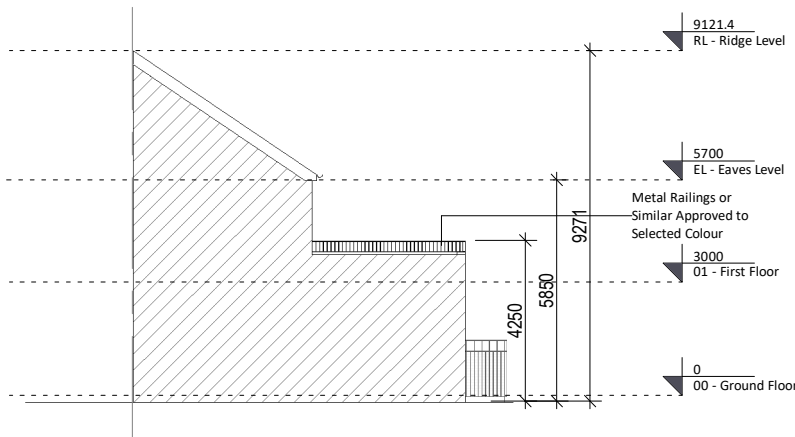

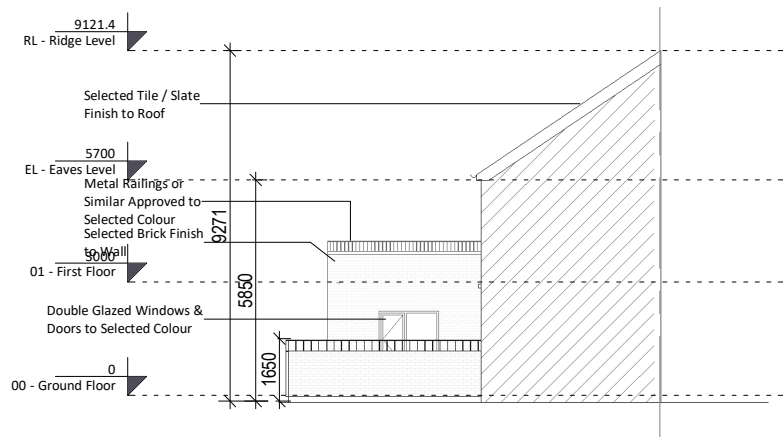
② First Floor

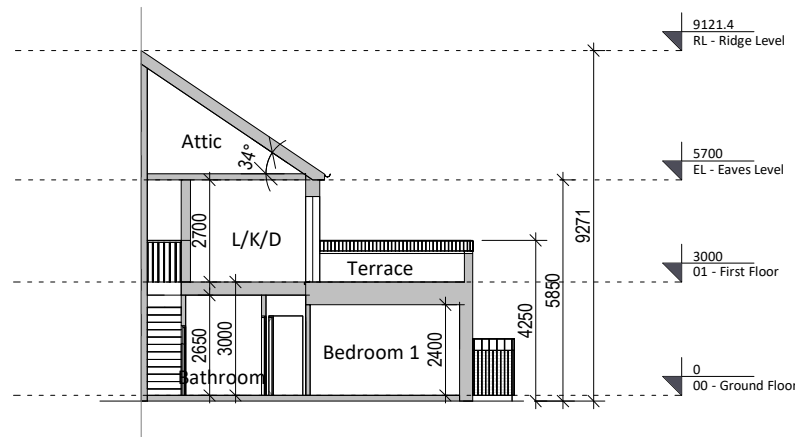
③ Front Elevation

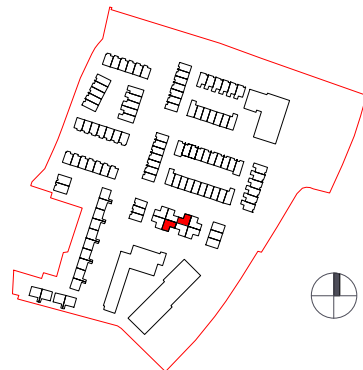
